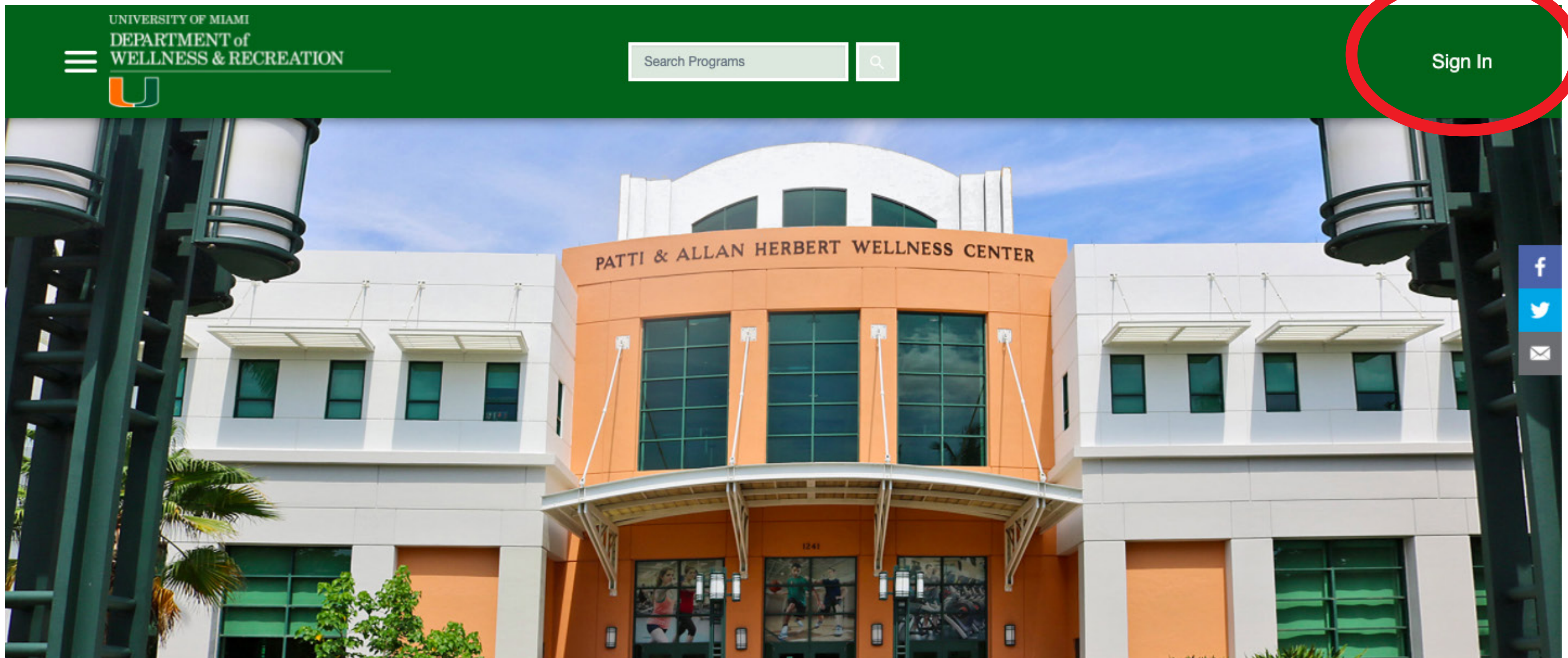
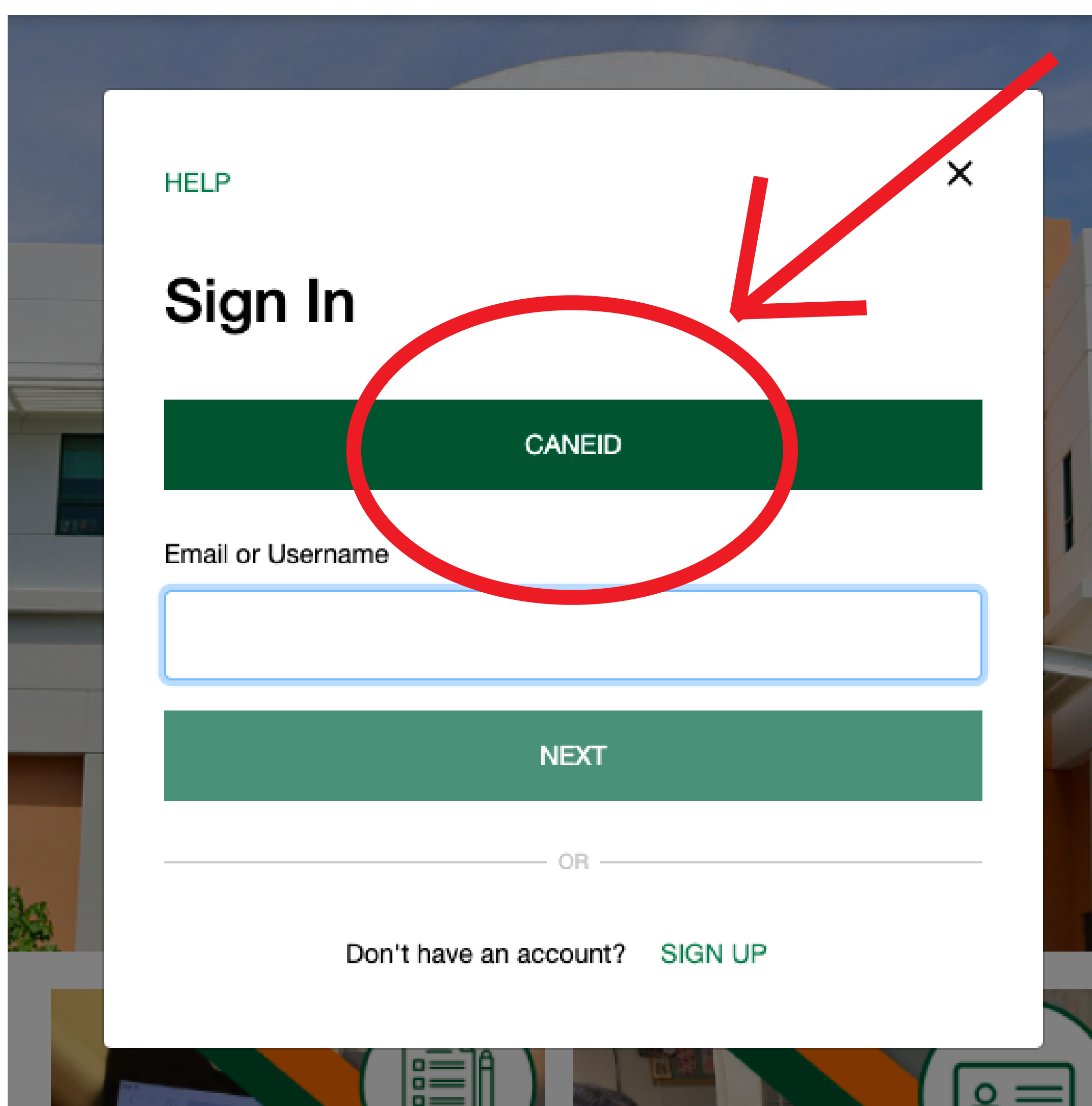

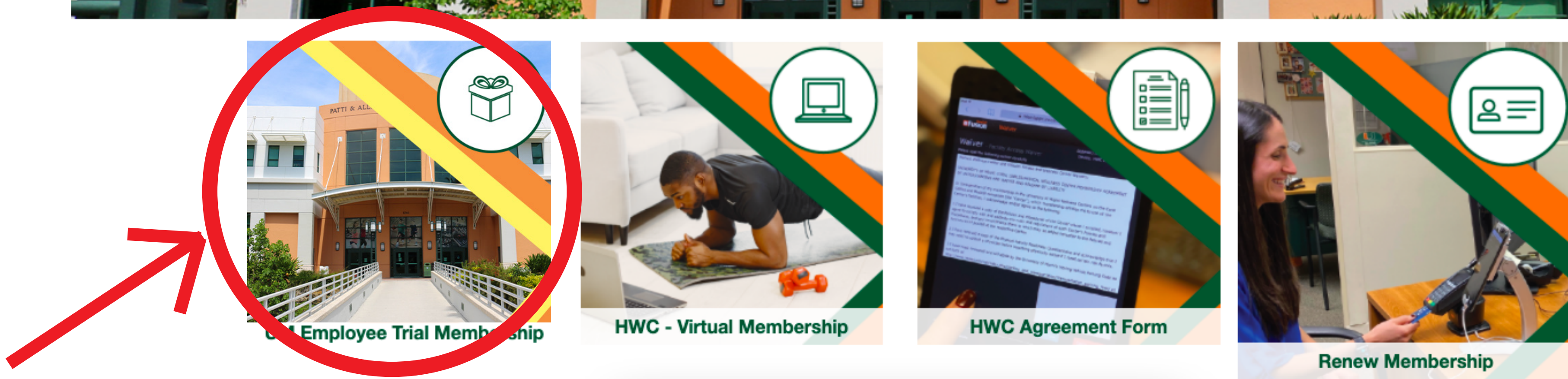
**1. Click Sign in on top right corner**


